- · disclosing identities of successful applicants by way of announcement(s) or otherwise;
- disclosing relevant information to facilitate claims on entitlements; and
- any other incidental or associated purposes relating to the above and/or to enable the
 Company and the Hong Kong Share Registrar to discharge their obligations to holders of
 Shares and/or regulators and any other purpose to which the holders of securities may fron
 time to time agree.

3 Transfer of personal data
